Kathleen Turco is a Director, Consulting in the Security, Administrative, Judicial and Enforcement Programs (SAJE) business unit within CGI Federal, a wholly-owned U.S. operating subsidiary of CGI Group, Inc. In this role, Ms. Turco teams with business unit heads on the development and execution of the business and solutions strategy for a diverse client including the United States Department of Agriculture's Shared Service.

Prior to CGI, Ms. Turco served for over 30 years with the Federal government where she retired as a Senior Executive with the Veterans Affairs Department after serving as the Chief Financial Officer (CFO) for the Veterans Health Administration (VHA) from 2013 until 2015. As CFO, Ms. Turco she provided executive direction and had responsibility for VHA's medical care budget which annually exceeds \$60 billion.

Ms. Turco served at the U.S. General Services Administration (GSA) for nearly 11 years in two executive positions including Associate Administrator for Government-wide Policy (OGP) 2010 until 2013 where she worked to transform federal policies for travel, transportation, asset management and information sharing. From 2002 to 2010, Ms. Turco served as GSA's CFO from 2002 to 2010 providing executive leadership of GSA's Performance Management Process including the agency-wide strategic planning and performance budgeting of \$56 billion in revenue and \$19 billion in expenditures within the enterprise management fee-for-service revolving funds, managed the core financial system and oversaw the financial Shared Services operations.

Ms. Turco held two positions at the Internal Revenue Service, where she served from 1998 to 2002, including the CIO's Director of Financial Policy, Planning and Programs (2001 to 2002) overseeing financial planning for IRS' business systems modernization and information services \$500 million in business systems technology investments and \$1.5 billion in systems operations. Ms. Turco also served as the IRS' Deputy CFO for Strategic Planning and Budgeting (1998 to 2001), directing the strategic planning, budget policy and financial execution of the \$8 billion IRS budget. From 1988 to 1998, Ms. Turco was with the Executive Office of the President (EOP) at the Office of Management and Budget (OMB) on both the budget and management sides.

Ms. Turco has been recognized for her government-wide work in financial management and acquisition policy with the 2010 American Council for Technology (ACT) President's Award and was the recipient of the prestigious Donald L. Scantlebury Memorial Award for Distinguished Leadership in Financial Management Improvement in 2008. She received a 2006 Presidential Rank Award as a Meritorious Executive.

Ms. Turco holds a Masters of Business Administration from the University of West Florida and a Bachelor of Science from the University of Maryland.
